THE FARMERS SPENT TWO WEEKS IN WASHINGTON D.C. AND MARYLAND DURING WHICH THEY RECEIVED TRAINING FROM THE AGRICULTURAL EXPERTS AFFILIATED WITH THE COLLEGE OF AGRICULTURE AT THE UNIVERSITY OF MARYLAND. IN ADDITION TO IMPROVING THEIR AGRICULTURAL SKILLS, THE GOAL OF THIS PROGRAM WAS TO SHOW TURKISH FARMERS THE BENEFITS OF HAVING A FARM EXTENSION SYSTEM THAT EMPHASIZES COLLABORATION BETWEEN FARMERS AND AGRICULTURAL EXPERTS.

IN MAY 2014, HASNA SENT A VOLUNTEER AMERICAN TEACHER TO DIYARBAKIR, TURKEY FOR THREE WEEKS. THE VOLUNTEER TEACHER TAUGHT ENGLISH READING 4b (Code:) (Expenses \$ 89,610. including grants of \$ 25,000.) (Revenue \$) CYPRUS: IN CYPRUS, ONE OF THE MOST SIGNIFICANT WILDLIFE CRIMES INVOLVES CAPTURING AND KILLING BIRDS AS THEY MIGRATE FROM EUROPE TO AFRICA, USING THE PREY FOR FOOD. TODAY, DESPITE AN OFFICIAL GOVERNMENT BAN ON THE PRACTICE, ESTIMATES OF AS MANY AS 2.5 MILLION BIRDS ARE KILLED EACH YEAR. A TRAINING WORKSHOP WAS ORGANIZED BY TERRA CYPRIA, TO INTERVENE IN THE TRANS-GENERATIONAL PRACTICE OF BIRD-TRAPPING THROUGH EDUCATIONAL MEASURES AND THROUGH THE TRAINING OF LAW ENFORCEMENT OFFICIALS, PROSECUTORS, AND JUDGES INVOLVED IN WILDLIFE CRIMES. THIS TOOK PLACE IN JANUARY 2014, ALTHOUGH A PORTION OF THE TOTAL PROGRAM COST WAS PAID BY HASNA INC. IN 2013.
